Performa Invoices are unacceptable. Customs will no longer accept commercial invoices containing statements as follows: Shipment value for customs purposes only", "no commercial value or N.C.V.", "value for statistical purposes only". All commercial invoices must be originals and must show the letter-head of the company.

1. National Health(SNS) or Agricultural(SAG) requirement must be fulfilled before release. Phytosanitary Certificate must be attached to AWB. Must pay additional charge to corresponding control service before clearance. Clearance delay: 2 w-days. Inspection-cost: USD 10. Formal clearance required.
2. Invoice must state actual value of goods.
3. AWB must be consigned to same person as on prescription. If for commercial purposes, a Certificate of Servicio de Salud of Chile (Health Department) is required prior to clearance. Duties/taxes are 32% over CIF value.
4. All material censored by government prior to release, delay: 3 days. Additional charge of USD5.00 per video or film. For censorship purpose all content for this kind of material must be declared in the commercial invoice.
5. Entertainment, advertising or musical clips.
