- Encephalopathy) product by Korea Medical Product Trade Association stating that the shpt is free from mad cow disease.*
- 3. Quarantine test by customs, delay: minimum 5 days.*
 - 4. Component analysis table required. Shpt must fulfill IATA Dangerous Goods Regulations.*
 - 5. For CD Rom containing game software, consignee requires import permit. Game software made in Japan is prohibited.*
 - 6. For cosmetics made of cow products, consignee to provide Cert of non-BSE (Bovine Spongiform Encephalopathy) product by KR Medical Product Trade Association stating that the shpt is free from mad cow disease.*
 - 7. Component analysis table req. Drugs & health products eg. DHEA, melatonin & vitamins are limited to 100 capsules/tablets as a gift. Viagra is prohibited except via formal import procedure i.e. consignee must be authorized locally.*
 - 8. Canned/tinned products only.*
 - 9. Please contact Customer Service. Must be packed with cooling device.*
 - 10. Acceptable only for military bases or military officers.*
 - 11. Must be properly packed. Please contact Customer Service*
- 2. 12. Soil must be completely removed. Quarantine test by customs, delay: 2-3 days.*
- 13. Subject to Quarantine test, delays: 2-3 days.*
 - 14. Toy guns: Prohibited.*
