- 1. Sample only, provided consignee holds a special import licence for liquor.
- **2.** Processed: Prohibited. Pork is prohibited but can be imported only if consignee holds a special import licence, delay: 12-24 hrs.
- **3.** 24hr pre-alert reg. before uplift of Chemical Re-Agents.
- 4. Subject to approval from Telecom dept; delay: 1-3 days.
- **5.** Drugs imported for personal use should have doctor's prescription. Medicines will be released only after approval from MV's Ministry of Health. Delay: 12-24 hrs.

- **13.** Duty free for vessels in transit. Commercial invoice must clearly state "Ship spares for vessel in transit". Authorisation from consignee required; delay: 24 hrs.
- 14. Full description of the contents require in the invoice.

Service Impact Notes

Temporary imports are entitled for duty free but the goods have to leave the country within 20 days from the date of arrival. If this duration is exceeded, the consignee has to pay duty charges depending upon the product.
